OFFICIAL RULES**

The Client ***NDI Heating, Cooling & Plumbing will conduct the K-BULL 98.1 RENO RODEO KICKOFF CONCERT TICKETS GIVEAWAY*** on their website at <https://ndireno.com/> substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

**Eligibility.** This Contest is open only to legal U.S. residents of the Station’s Designated Market Area (“Reno DMA”) as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last **30 days (about 4 and a half weeks) from NDI or KBUL FM** and whose immediate family members or household members have not won a prize from the Station in the last **30 days (Void where prohibited by law.** Employees of Station, NDI Heating, Cooling & Plumbing and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station’s DMA, and the immediate family members and household members of all such employees are not eligible to participate.
